Subject:

Incurring of expenditure under Plan schemes.

Refer to the Finance Department's U.O. No. 5/6/2005-5B&C, dated 26<sup>th</sup> March, 2009 on the subject noted above vide which the Administrative Department had been allowed to incur expenditure under the approved plan schemes upto 25% in 1<sup>st</sup> quarter, 20% in 2<sup>nd</sup> quarter, 25% in 3<sup>rd</sup> quarter and 30% in 4<sup>th</sup> quarter without any reference on this account to the Finance Department.

- It has been observed by the Finance Department that in the month of February/March, some of the Administrative Departments draw unspent money under various plan schemes and distribute it either Boards/Corporations or simply release it to the field offices/DDOs for drawing from the treasury and putting in some bank accounts for spending later-on. The money drawn in this manner is not only liable to be misused but also is a violation of the Financial Rules. This practice needs to be curbed. Accordingly, it has been decided that expenditure under any State Plan Scheme in the last quarter of the financial year will not be more than 25% of the total budget in that scheme if the expenditure incurred in such scheme upto end of the month of December is less than 50% of the total budget. Some illustrations are as follows:-
- Illustration No. 1: Budget allocation ₹10.00 crores. Expenditure upto 31<sup>st</sup> December, 2013 is ₹4.00 crores. In this situation the department is authorized to spend only ₹2.5 crores out of the remaining allocation in the last quarter.
- Illustration No. 2: Total allocation ₹10.00 crores. Expenditure upto 31<sup>st</sup> December, 2013 is ₹6.00 crores. In this situation the department can spend the entire remaining 40% in the last quarter.
- Illustration No. 3: Total allocation ₹10.00 crores. Expenditure upto 31<sup>st</sup> December, 2013 is Nil. The department can spend only ₹2.5 crores out of the remaining allocation in the last quarter.
- Further, in all cases of sharing schemes or centrally funded schemes, expenditure in the last quarter should be incurred only if the corresponding share of the Central Government has already been released by the Government of India and in no case total expenditure during the financial year from the State Share should exceed the proportionate State Share. In cases where incurring of expenditure from the State Share is pre-requisite for release of Central Share, it should be ensured that further expenditure in the last quarter of the year is incurred only if corresponding Central Share related to already incurred expenditure has been released by Government of India.
